# **CAVY SCHEDULE**

### **RULES AND CONDITIONS**

- 1. Cavies will be judged in accordance with the standards and general Show Regulations as provided by the ANCC.
- 2. One Cavy per handler.
- 3. Best of Breed will be awarded at the Judge's discretion.
- 4. All cavies exhibited at this Show must be pure bred pedigree cavies. They must be entire. (not de-sexed). Any cavy found not to be entire will be disgualified.
- 5. Sick or lice infested cavies will be removed from the Pavilion.
- 6. Stock purchased from a cavy judge cannot be exhibited under that judge at a show until the expiration of three months from the date of purchase.
- 7. No speaking at the Judging Table, either to your neighbour, or the Judge, unless the Judge speaks to you.
- No one to go behind the judging table while judging is in 8. progress.
- 9. All cavies, apart from longhairs, must be shown on carpet squares. Only longhairs can be shown on cushions/boards suitable for their breed.
- 10. A judge may order any person or cavy from the competition for bad conduct of one or both.
- 11. The Judge's decision is final.
- 12. Entries will only be accepted from financial members of clubs affiliated with the ANCC.
- 13. No substitute cavies will be permitted.
- 14 Exhibitors are not to leave the Pavilion early unless special permission is sought from the Show Manager. Cavies should remain on display for the general public until 3.00pm.
- 15 In addition to any special regulations herein all Exhibitors in this section are subject to the General Regulations for Competitors and Exhibitors of the Huon Agricultural Society Inc.
